Mr. Hanley welcomed all in attendance. He shared that Dr. Farrelly was not present as she was attending her daughter's "Back to School Night". On behalf of the Board of Education and central administrators, Mr. Hanley welcomed all back to the new school year. He said throughout this week, the central administation team walked through the buildings to welcome students, staff, and faculty to the start of school. The Board, Dr. Farrelly, Mrs. Psarakis and Mr. Graziano conducted the required annual walk through on August 30th. All buildings were ready for the first day of school. Mr. Hanley thanked the Buildings and Grounds Department.

Copies of the Superintendent's Staff and Faculty Newsletter, which included district-wide updates, were available on the counter and provided to the trustees.

Eagle Scout Liam Reiff's September 11th Memorial dedication was held this past Saturday. Dr. Farrelly attended along with trustees Ray Downey, Cathy Gismervik and Diane Klein. Dr. Farrelly shared with Mr. Hanley that the memorial turned out beautifully and that she would like to thank the SHS administrators for working with Liam to see the project through to completion.

On Thursday, September 13th, the Primary 2018 election will take place in the following schools within our district: FA, JFK, SA, JHS and SHS-Gym B.

Last week, Dr. Farrelly received 3 parent emails regarding the hot weather and air conditioning within the district school buildings. As a result, for informational purposes, we worked with BBS, our architects, to get estimates on air conditioning our classrooms throughout the district.

- The first estimate is to provide window units for all classrooms, including DDC interlocks with the existing unit ventilators. The total cost of this includes the other spaces as well, and encompasses the three gyms at the High School. We estimate the cost of this work to be \$15 million not including any electrical service upgrades.
- The second estimate is to provide ductless splits for each classroom, again, including DDC interlocks with the UVs.
 The total cost of this scenario is estimated to be \$23 million.
- The third scenario is to replace the unit vents with UVs capable of cooling using VRF technology. This is the most costly alternative and the estimated cost is \$34 million.
- If the Board pursues this, we would need another bond referendum... Dr. Farrelly will bring this topic up again during the next BOE meeting for discussion.
