# Procedural: B. Statement of the Board and/or Superintendent

Dr. Farrelly opened the meeting by extending her congratulations to Mr. McKeon, Ms Mauro, Mr. Salas, Mrs. Limperatos, Mrs. Craig and all the others involved in the St. Baldrick's fundraiser event. It was a huge success and over \$41,000 was raised. District students, staff and faculty were brave enough to have their heads shaved. Dr. Farrelly said, unfortunately, she was not able to attend, but was receiving pictures throughout the whole event which she posted to social media. Dr. Farrelly shared that the group will be recognized for all their efforts at a future Board of Education meeting.

STEM night was a huge success. Dr. Farrelly thanked Aimee Mendoza, as well as the Senior High School teachers, students and administrators. Pictures from the evening's event were posted on the district website and social media.

The PTA Founder's Day celebration was also a great success. Our PTAs recognized many wonderful individuals who go above and beyond for our students. Dr. Farrelly thanked the PTAs for their dedication to the district.

Dr. Farrelly highlighted the following: the JHS Drama Club is presenting "The Sound of Music" on March 21st and March 22nd at 7:00 PM in Eagle Hall; Mrs. Gina Curcio, K-12 Guidance Chairperson, has been invited to present a Guidance Department update at the April 30th Board of Education meeting; the District will be offering the after school SCOPE STEM enrichment program for K-5 students from March to May and registration will occur in the next few weeks; all were invited to review and enjoy the latest issue of the Superintendent's "Points of Pride-February 2019" (copies on the counter) which highlights West Babylon's accomplishments. The week of March 3rd to March 8th is school social worker's recognition week. Dr. Farrelly asked all to join her in recognizing the wonderful dedication of the social workers whose day often extends beyond the set workday hours. They provide ongoing support to many students and families.

As an FYI - Dr. Farrelly indicated the Board of Education candidate petition packets are available from the District Clerk in the Administration Building.

Representing the Suffolk County School Superintendents Association ("SCSSA"), Dr. Farrelly attended a meeting, with her superintendent counterparts, with SCPD Chief Cameron relating to school safety and security. She and her fellow superintendents continue to be thankful for the ongoing collaboration with the SCPD.

At this point, Dr. Farrelly said she would like to recap the meetings held since the last Board meeting (2/12/19) regarding policy decision to move forward with armed guards. She said she has held 4 volunteer meetings with staff and faculty members. In addition, she has met with senior high school student leaders. She has responded to all community/parent emails and has held several meetings (individual and small group) with parents who requested meetings. Mr. Hanley, Assistant Superintendent for HR, and Mr. Salas, Director of School Safety, have participated in some of these meetings. Mr. Hanley and Mr. Salas have also met with the PTA Council.

Common questions throughout these meetings were relating to:

- The process the Board went through to arrive at this decision...concerns were posed regarding not having a public forum... whether or not it is legal for the Board of Education to make this decision... Dr. Farrelly indicated that she shared with all who she met with that this was not an easy decision for the Board. For months, the Board carefully considered all aspects of this decision and ultimately made their decision on February 12th. This is a policy decision that can and has been made by the Board.
- Selection of armed guards Dr. Farrelly indicated that only former or current law enforcement officers will be interviewed and considered for these
  positions in the next few months.
- Specific placement of armed guards Dr. Farrelly indicated the exact location of armed guards would not be disclosed as this would compromise their safety and our safety plans. She also stated that there has been no decision to have the guards walking regularly through the school hallways.
- Specifics regarding the armed guards schedules i.e. start/end time? ... Dr. Farrelly indicated we cannot disclose that information because it would also compromise the safety of the guards and our school safety plans.
- Are we more vulnerable or more at risk or have more safety concerns then other school districts. Per Dr. Farrelly the answer is "NO absolutely not." As previously shared, Dr. Farrelly indicated that students across all socioeconomic status and ethnicities are struggling with mental health needs. This is not unique to our school district, Suffolk County or across the nation.
- And last, specific scientific research that suggests that having armed guards would make the District safer has been requested by various
  individuals. Dr. Farrelly indicated no such research exists at this time. There is not enough data to suggest it one way or another. The general
  feeling of our Board of Education is that this is only one piece of many aspects of the district's safety plans...that it may be a deterrent... Of course,
  hopefully we will never know.

# Procedural: B. Statements of Residents re: other district items [15 minutes-limited to 3 minutes per speaker]\*

The following West Babylon residents and a West Babylon SHS student made comments or read statements. Comments/statements highlights included the following:

- Ms. Rachel Scelfo, West Babylon resident, said she respectfully disagreed with the Board's policy decision and indicated she did not support the
  decision to hire armed guards. She indicated there was a failure of the Board to publicly disclose details. Concerns noted regarding there not being
  a public hearing on this topic.
- Mr. Daniel McCarthy, West Babylon resident, said he was grateful that the BOE took on this controversial topic. He felt the BOE made a conscious decision (to hire armed guards) and felt appreciative that the BOE relied on expert advice and not lay people's emotions. He shared that all are in agreement that we want to put our children on the school bus in the morning and have them come home at the end of the school day. Mr. McCarthy noted that April 20, 2019 is the 20th anniversary of Columbine 20 years later the issue of who to protect our children is still being debated. He also stated that he had full confidence that the Board and Superintendent will come up with a good plan to protect our children. He indicated he did not need to know about the details and thanked all for doing this.
- Ms. Brianna Collora, WB SHS student, read a statement. She indicated she felt it is a smart decision to hire armed guards. She stated many SHS students are in support of this decision, but the students' opinions are being overlooked. Ms. Collora emphasized that schools are supposed to be one of the safest places and she felt the youth is not as protected in schools as people are in courtrooms or in airports. She noted everyone has gone through some type of security at a concert or at a public event and celebrities and politicians have security protection. Ms. Collora indicated after Columbine, after Sandy Hook, after just 1 death, we should have fixed this. She shared that WB has the opportunity to be proactive, fix this here and come together to protect our teachers, students and schools.
- Ms. Maryann Pineda, West Babylon resident, stated there was a "lack of transparency". She emphasized the topic should have been open for a
  public vote.
- Ms. Amanda Ferguson, West Babylon resident, stated she did not support armed guards. She is concerned with risk vs. human error. She also noted concerns regarding the weather/activities canceled robocall.
- Ms. Leslie Cozzi, West Babylon resident, stated she understood this was not an easy or quick decision and thanked the BOE for dealing with it.
   Community support is important; no answer will fix everything. Armed guards is just one component of the multifaceted issue. All the components WB is thinking of mental health, additional social worker, guidance counselor, etc. are a start. Also, in relation to Parkland and the armed guard running from the scene that was one incident in general if a law enforcement officer/guard signs on for this type of job, especially a retired person, most likely he or she will be committed to the safety of our children. Ms. Cozzi said thank you for looking out for our children.
- Mr. Chris Bilello, West Babylon resident, thanked the Board and superintendent for making this tough decision. Mr. Bilello indicated we elected a
  Board and sometimes that Board has to make a decision which is right, but not popular. In the incidents mentioned tonight Columbine,
  Lancaster, Virginia Tech, Newtown, Parkland, the shooting stopped when someone entered the building. Mr. Bilello indicated he would like to
  applaud the BOE for not waiting until Albany makes a decision. He stated this is a learning experience and shared it is important to look at the
  history of these other incidents and learn from those situations. Mr. Bilello thanked the BOE for doing so.
- Mr. Jay McGraw, West Babylon resident, thanked everyone for taking the time and the diligence to make this decision. Mr. McGraw indicated he supports it 100 percent and noted if it wasn't done now, and an incident occurred in WB, the community would be in an uproar over nothing being done and nothing being put in place. Mr. McGraw emphasized we can't say this won't happen here in WB... we live in a different world now... just have to hope it doesn't. He again thanked the Board.
- Mr. Richard Camarda shared he is undecided as to whether this is a good thing or not, but puts his trust in the process that the BOE and Superintendent went through particularly the issue of "Rules of Engagement" and the technical aspects of the decision discussed by the Superintendent. Mr. Camarda thanked the Board and would like the policies that are to be developed placed on the website.
