Procedural: B. Statement of the Board and/or Superintendent

Dr. Farrelly opened the video conference meeting and asked all to share in a moment of silence for all those lost during these past few weeks.

Dr. Farrelly continued on to share the following:

"I hope you and your family are healthy. My deepest condolences to families who have lost loved ones. Please know that you are in our thoughts. Please I ask for a moment of silence for all who have lost their lives as a result of coronavirus. Thank you.

At this time I would like to provide several updates regarding our closure.

Closure/Distance Learning: The COVID-19 crisis has certainly created a paradigm shift in all aspects of daily living...including public education. We have moved from classroom instruction to distance learning without warning or ample opportunity for appropriate preparation, training, and experimentation. Despite these obstacles, our teachers and administrators are all working diligently to learn and simultaneously implement as we move along. Our students and parents are also learning and quickly engaging in this new system. As a West Babylon family, we are all working together to support one another throughout these unprecedented times.

Yesterday, Governor Cuomo extended school closures until April 28th. As such, our teachers will continue utilizing our distance learning platform (Google Classroom, Google Hanqout, etc.) until we are cleared to return to our school buildings. Curricular expectations have been shared and posted online. We continue to allow every teacher to use their own professional judgment and instructional determinations as to what is best to help students find success with the curriculum. They will guide your students with this process and be available to assist as they always have. Some teachers are using live video conferencing (Google Hangouts) to achieve this connection with students. Other teachers have used elements of Google Classroom, email (noting specific time frames to be available for immediate support/response), pre-recorded videos, and phone calls (with the use of *67 to block caller ID) to make connections with students and/or parents. Please be patient with our teachers and administrators as most of us are learning these new live virtual platforms. Huge thank you to Mr. Payne for working with our building administrators to spearhead our distance learning. Also, thank you to Mrs. Nocerino, ITS, security department and all involved with the distribution of computers to almost 800 families in West Babylon.

State Assessments: The Board of Regents and Department have canceled 3-8 assessments as well as the June 2020 administration of the NYS High School Regents Exams. A few minutes ago, the Department has announced modifications to the requirements that students must meet in order to earn high school diplomas, credentials, and endorsements. These modifications apply to all students enrolled in grades 7-12 during the 2019-20 school year who were intending to participate in one or more of the June 2020 Regents Examinations. Information relating to graduation requirements will be sent to our secondary families and students.

Grades: The third quarter grades for the secondary level have been determined based on a close date of March 13th (which was the last day students were present in school). In the next few days, we will be meeting to determine grading policies for the 4th quarter (grades 6-12) and 3rd Trimester (grades K-5). Once determined, this information will be shared by your building principal.

WB Budget Vote and Trustee Election have been postponed until at least June 1st. Accordingly, due to this postponement, customary deadlines will also move at least two weeks and could be adjusted in other ways by Governor's Executive Order. We are not

conducting a budget presentation tonight because there are several unknown factors at this time. Of crucial importance is that the state budget includes a mechanism authorizing the Governor's Budget Director to adjust - to cut - most state-local spending that includes school aid, in the event that state revenues come in more than 1% below projections or if expenditures are more than 1% above projections. Since the income tax deadline has been extended from April 15 to July 15, we could see our first state aid reductions impacting the 2019-20 school year. Please be aware our district receives approximately \$35 million in state aid (this equates to 29% of our total budget) as a result budget adjustments may be necessary. Our next 2020-21 budget presentation will be done on April 28th. This will allow us time to make necessary budget adjustments based on information we receive up until that day. If the budget and trustee election occurs during the first week of June, we will likely have a budget hearing and adopt our budget on May 5th.

Playgrounds/School Grounds and Buildings continue to be closed.

All construction has been stopped throughout the district.

Breakfast and Lunch Distribution continues at the JHS. Thank you to Mrs. Frabizio, Mrs. Psarakis, our lunch department, and all others involved in the distribution.

End of Year Celebrations: We understand and recognize that our students, staff, and families are also worried about not having our wonderful end of year celebrations - graduation ceremonies, prom and Blue and Gold - just to name a few examples. Please know that once we return to our school buildings and social distancing directives are no longer in effect, we will do our best to reschedule special events for our students and families.

And last, as an FYI, tomorrow evening, if the technology works in our favor, SCPD Commissioner Hart and I will be doing a joint robocall to our community members urging everyone to adhere to the social distancing and other directives being given to safeguard everyone. In closing, I would also like to thank all of our first responders, including our healthcare workers, who are working on behalf of our community. No further statements Ms. Campasano."
