

## MINUTES OF REGULAR BOARD OF EDUCATION MEETING OF JUNE 28, 2022

**Presentation: A. Varsity Cheerleading Team and Girls Varsity Basketball Team Plaque Presentation: Dr. Yiendhy Farrelly, Superintendent of Schools; Mr. Lou Howard, Director of Athletics, Mr. Richard Schaffer, Town of Babylon Superintendent**

Dr. Farrelly welcomed all to the meeting. Dr. Farrelly said that it is her honor to present to the Board Trustees this year's Long Island Champions - our WB Varsity Basketball Team and WB's Cheerleaders. She shared that all are very proud of the hard work and outstanding season both teams had. In acknowledgement and on behalf of the Board of Education, Administration and the coaches, Dr. Farrelly turned the presentations of the plaques over to Mr. Howard. Mr. Howard shared that Town of Babylon Supervisor Richard Schaffer was in attendance and thanked him for the "congratulatory" outdoor signs the Town donated to the school district in acknowledgement of both teams successful seasons. Mr. Schaffer, along with Town Councilman Dwayne Gregory and Town Councilman Terence McSweeney, handed out Town of Babylon proclamations to the team members. Dr. Farrelly and Board President Lucy Campasano thanked Mr. Schaffer for the constant support of the district's schools, students and programs.

Dr. Farrelly thanked Mr. Hanley and Mrs. Psarakis for their service as Presidents of the Long Island Association of School Personnel Administrators and the Association of School Business Officials, respectively. She acknowledged the work involved when holding the position of association president and thanked both of them for representing their fields and our district so well. Both associations also provided SHS students with scholarships.

**3. REPORT OF THE SUPERINTENDENT AND/OR EDUCATIONAL PRESENTATION****Presentation: A. Cullen & Danowski-2021-2022 External Auditors Financial Audit Presentation: Mrs. Michele Psarakis, CPA, Assistant Superintendent for Finance & Operations**

Dr. Farrelly introduced Mr. Michael J. Leone, Engagement Partner. Mr. Leone provided copies of the audit presentation to the Board of Education trustees. His overview highlighted the following: Engagement Objectives; The Audit Engagement; Auditor's Responsibilities; District's Responsibilities; Audit Methodology & Approach; Timetable; Engagement Team; and Recent Developments. The Audit Planning & Risk Assessment Phase relating to control Evaluation and Tests took place during the week of April 25, 2022. Throughout the week of August 22, 2022, the Substantive Testing Phase will consist of completion and reporting. At the September 28, 2022 Board meeting, the firm will present the draft audit reports. By March 31, 2023, the Federal Single Audit will have taken place. Board President Lucy Campasano and Dr. Farrelly thanked Mr. Leone and the firm for their partnership and guidance.

**Presentation: B. West Babylon UFSD School Emergency Response Plan Presentation: Dr. Yiendhy Farrelly, Superintendent of Schools**

Dr. Farrelly said tonight's presentation is the same presentation rescheduled from the June 14th Board meeting. She began by thanking Mr. Brian Wallace, Senior Security Guard, who joined her tonight for the presentation. Dr. Farrelly reviewed the plan slide by slide. She shared that throughout the last 7 years, the district has held many public Board meeting presentations regarding safety and security. She highlighted the following during the presentation: the Building Emergency Response Plans and the District-wide Response Plans. She spoke about the following "procedures" in place: Medical Emergency; Bomb Threat; Fire Evacuation; Evacuation/Staff All Call procedures; Shelter-in-place; Hold-in-place; Lockout; and Lockdown. Dr. Farrelly reviewed the emergency drills that are conducted district-wide throughout the school year. She explained the Parent/Student Reunification process. Regarding school messenger notifications, Dr. Farrelly said the district will be shifting to a new communication system - Parent Square. Information will be sent to families this summer. In addition, she reviewed safety & security personnel training and the district's partnership with the Suffolk County Police Department. Dr. Farrelly also addressed student mental health needs. Next year (2022-2023), the district will have increased its social workers staff from 3 (4 years ago) to 9 (one at each elementary school, 2 at the Junior High School and 2 at the Senior High School). Dr. Farrelly introduced and welcomed two new social workers who were in the audience, Christine Papadatos, South Bay School, and Brittany Dein, Santapogue School. The presentation is on the district's website.
