3. REPORT OF THE SUPERINTENDENT AND/OR EDUCATIONAL PRESENTATION

Presentation: A. Board of Education Annual Professional Development Presentation: Dr. Yiendhy Farrelly, Superintendent of Schools; Mr. Shawn Hanley, Assistant Superintendent for Human Resources

Dr. Farrelly highlighted a few topics relating to the Board of Education procedures and protocols, especially for the new Board members. Among those topics, were:

He advised the Board about Board of Education Policy sign off sheets for Code of Ethics, Code of Conduct and Sexual Harassment. Mr. Hanley elaborated on the Sexual Harassment regulations, what it actually means, what it entails and examples while at work.

Mr. Scott Payne, Assistant Superintendent for Curriculum and Instruction provided a quick overview of Atlas.
