Information, Procedural: B. Statement of the Board and/or Superintendent

Dr. Farrelly thanked the community for joining. She began her report with a few general statements.

The Board of Education and administration team have been discussing and exploring cost saving measures and ways to increase district efficiencies and revenue for our school district.

The cost of NYSHIP health insurance for the school district and all school districts has been astronomical. Each year, the board and community members gasp when the district highlights the annual increases in health insurance. During budget presentations, it was shared that in January 2024, health insurance increased by 1.9 million and an additional increase of 1.5 million is projected for the upcoming school year. To address this fiscal challenge, the Board requested that we explore alternative health insurance carriers. As a result, the district began looking at options, provided the benefit structure remained substantially equivalent or better.

The district began by exploring a self-insured health insurance option currently used by several other school districts. Much time was spent meeting with their representatives as well as our district union leaders. In order to move forward with this option, a full 100% buy-in from all of our units was necessary. Since there was not full support to proceed - the exploration of this option ended.

Dr. Farrelly continued her report by noting that the District then began to explore options for NYSHIP secondary health insurance for retirees - and eventually all current employees, which brings us to tonight's informational health insurance presentation. No Board of Education action is scheduled. Dr. Farrelly noted that this is an informational presentation.

In addition, Dr. Farrelly remarked that as part of the district's long range financial planning discussions, during the June Board of Education workshop meeting, the Board met to discuss exploring additional cost saving measures and revenue enhancements for the district. As a result of these board discussions, Dr. Farrelly has established a Long Range Planning Committee to be facilitated by Mr. Mike Keany - former administrator - who has facilitated Long Range Planning Committee meetings for school districts for over 10 years. The Long Range Planning Committee will be divided into the following 4 Task Force Work Groups:

- 1. Researching Consolidating 5 schools into 4 schools following a Princeton model
- 2. Researching Consolidating 5 schools into 4 schools with the same k-5 grade configurations (Although not requested it will be important to gather information and analyze this as well since this is our current grade configuration)
- 3. Researching ways to increase revenue
- 4. Researching UPK Options

During the same Board of Education workshop meeting - establishing CTE programs in school districts and health insurance alternatives were also areas that trustees asked to be explored. These will be explored separately - not part of the charge of this Long Range Planning Committee.

Finally, Mr. Keany and Dr. Farrelly reviewed their calendar and selected biweekly Long Range Planning meeting dates from September through January. Dr. Farrelly will provide regular updates to the Board of Education. A final presentation from the Long Range Planning Committee would be presented by the committee to the Board of Education on January 28th for discussion, questions and answers from the Board of Education. The Board of Education's discussion (and action - if any) would take place during the February 11th BOE meeting.

Before moving forward, Dr. Farrelly respectfully requested the Board of Education confirm the proposed research areas and timeline. The Board was in unanimous agreement.
