OLD BUSINESS: Budget Draft #4 — Anthony Cacciola and Jennifer Buscemi

Mr. Cacciola explained that the district's cap is 3.64%. He said that he does not recommend piercing the cap as it is so close to the amount that the Board had originally targeted if they were to pierce the cap. Mrs. Buscemi presented the budget information for all to see. The information will be on the district's website tomorrow. He said if the cap is pierced 60% of voters would be needed for the budget to pass. He said that at this point his number one recommendation is to restore JV Sports and the JHS 9 Period day. Mr. Cacciola noted that the state has a budget and once he has the state aid restoration numbers, which should be in 2-3 days, he will look at other restorations. He said that his next recommendation if there are funds, would be to restore some music and art programs followed by clubs and intramurals. In response to Trustee Jenning's question Mrs. Buscemi said that transportation costs are aidable. Trustee Thiel clarified that full day kindergarten has been restored. Mr. Cacciola said that he doesn't usually post on Facebook, however, he needed to dispel rumors circulating that Santapogue School and JFK School are closing. He said that these buildings are not being closed.

NEW BUSINESS:

Trustee Thiel reminded everyone that the meeting originally scheduled for tomorrow evening was held on March 6. So, there is no meeting tomorrow evening. She said that she believes the Board needs to set a meeting before the April 17th meeting to review possible additional funds and where to best use them.

Trustee Thiel seconded by Trustee DeGaetano made a motion to hold a workshop meeting on Monday April 16, 2012 at 7:00 p.m.

Mr. Cacciola noted that addendum #BE-5 on this evening's agenda is the ratification of the paraprofessionals' memorandum of agreement. He said that the two year contract has a hard freeze in year one, no raises, all salaries frozen and a soft freeze in year two, which would only be step increases. In exchange, the workforce would receive two additional paid holidays. He thanked the unit for working for the best interest of the community.

STATEMENT OF RESIDENTS

Trustee DeGaetano asked about the process for the "Follow-up to Residents' Questions". District Clerk Amy Jones explained that if there were questions at a previous meeting, the question will remain on consecutive agendas until it is addressed. The response will be on an agenda. Resident Patricia Casey said that she was disappointed to see cuts to the arts programs which are part of the curriculum while maintaining extracurricular sports programs. She said that she is not bashing sports, she would just like the Board to take into consideration that the arts programs are often the only time during the school day for many students to be creative.

Students brought in their beautiful artwork for display for the administrators and Board members.

Residents Lorraine and Jack Cummings said they moved to West Babylon when their daughter was in kindergarten because it had the perfect educational setting. They thanked the Board of Education and administrators for providing this wonderful education for their daughter. They said that the arts are not necessarily the place to cut and implored the Board to reconsider the cuts to art and music. Mr. Cummings said that if the proposed 50% cuts to the art program are realized, the Board will see only 50% of the beautiful artwork seen this evening.

Resident Nancy Walsh-Smolenski said she would like the Board to consider a cost per pupil comparison to other districts. In addition, she would like the Board to look at the cost of programs, the number of students in the programs and whether the program is needed.

Dr. Palma clarified that 50% of art for grades K-5 and 2 Junior High School classes are being considered for cuts, not 50% of the entire art program. Resident Lisa DiGeloromo said that one of the classes being considered is the junior high studio art class which is a prerequisite for the high school program.

Resident Carolyn Casey said that the art program benefited her children and they were able to for to Cooper Union and FIT because of these programs. She said she can't stand the thought of another cut to the art program.

Resident Jane Babino said that she has two seven year old children. Her son is involved in sports and her daughter in the arts. She said that there needs to be more balance in the programs. She said that one of her children benefits from the programs and the other does not. Mrs. Babino would like to see more balance.

Resident William Hill said that he believes there are budget lines that could be cut to restore the music and arts programs.

Resident Rich Delmonico said that the music program positively affects students throughout their schooling.

Trustee Scarlatos seconded by Trustee Gismervik made a motion to Executive Session at 9:00 p.m.
